TERMS & CONDITIONS OF SALE OF THE PROPERTIES

- The final bidding shall be conducted through an online DYNAMIC SEALED BID auction process. The date and time of the online DYNAMIC SEALED BID auction shall be 18th February, 2021, @ 12 pm. all qualified bidders shall be informed in advance and proper training shall be imparted to the bidders by mjunction services limited.
- The H1 buyer has to pay 5% of the highest value given by him in the online auction as **Security Deposit** within 7 working days of price approval, EMD will be adjusted with the Security Deposit. The bank details will be shared with the H1 buyer.
- After the payment of Security deposit the buyer will be given all the relevant documents of the property with which he can do the searching and other required activities. But the buyer has to pay the full amount with the applicable tax(if any) within 30 days from the date of price approval. If any discrepancies are raised in deed or while searching the full security deposit will be refunded.
- All the online offers (bids) submitted by prospective buyers shall be kept valid for a period of at least 15 days for acceptance by TATA STEEL LIMITED. EMD of the non H1 buyers will be refunded within 5 working days after receiving refund request letter and relevant credentials.
